On February 9, 2022, ALLETE, Inc. (the "Company") announced that Steven W. Morris has been named Senior Vice President and Chief Financial Officer. In this position, Mr. Morris will serve as the Company's principal financial officer and its principal accounting officer. Mr. Morris, age 60, has served as Vice President and Chief Accounting Officer since December 2016. He also served as Controller from March 2014 until October 2021.

Mr. Morris succeeds Robert J. Adams as Chief Financial Officer. Mr. Adams, who in January 2022 announced his retirement plans, will retire from the Company on June 17, 2022.
