Item 8.01 Other Events

On May 24, 2016, ALLETE, Inc., through its operating division Minnesota Power, entered into multiple agreements with Cliffs Natural Resources Inc. ("Cliffs") and its subsidiaries. Under one of the agreements, Cliffs received \$31 million in cash as part of a long-term purchased power arrangement for its Northshore Mining - Silver Bay operations with Minnesota Power through 2031. The agreement, pending potential regulatory approval of the purchase of utility assets, includes certain non-core transmission assets at United Taconite, certain land options at United Taconite and Northshore Mining Company, and transportation rights along the Cliffs Erie rail assets. Separately, Minnesota Power extended its regulated power purchase agreements with Cliffs for 10 years at Cliffs' United Taconite and Babbitt facilities, subject to regulatory approval.
